## Jewish Reflection on Immigration – Multi-Faith Vigil, 4/3/25, on the "Sensitive Locations" lawsuit joined by many religious groups

Honored to be here with you all. To see why so many Jewish groups want to keep ICE out of our houses of worship, consider the three Hebrew words for 'synagogue':

Most obvious, yet least common, is **Beit Tefilah**, house of prayer. Jewish prayers are mostly in the plural – over and over we hear the suffix *nu*, the word *anachnu*, WE, US. Similar is our notion of a *minyan*, a prayer quorum – if nine are gathered, we'll wait for you, or you: *every*one counts. And of course, the prophet Isaiah's famous hope: *veiti*, beit tefillah yikare l'**chol** ha'amim -- God says, "let My house be a house of prayer for ALL peoples." All – no exceptions.

A more common name for synagogue is **Beit Sefer** – house of the book, house of study [school] – as all our sanctuaries are places for learning as well as for encounter. So what exactly *do* we learn, when we open our Torah, our Bible? Tonight, just two top texts – oftcited; one already by Rabbi Liz Hirsch – but they're worth repeating, until the politicians who piously proclaim their 'faith' truly hear and heed these words:



Genesis 1: "b'tzelem Elohim bara oto, in God's own image did the Holy One create humanity." Every person, since the first mythical Eve & Adam, actively bears the divine image – so all are entitled to decency, to fair treatment, to due process, to respect – no exceptions.

And Leviticus 19:33-34 (here it is again; memorize this): "When a foreigner, a *ger*, resides among you in your land, *do not mistreat* them. The foreigner residing among you must be treated <u>as</u> your native-born. <u>Love them</u> as yourself – *v'ahavtem et ha'ger*! – for you were foreigners in Egypt. I am the Lord your God." [that last line is the Torah's exclamation point!]

Clearly, Torah embodies a great ethos here. Important as tomorrow's case is, dream with me for a moment: imagine if we could all be plaintiffs on a suit demanding more: a respectful reset at our borders; an immediate end to caged detentions and family separations and roundups of people whose only so-called 'major crime' was crossing the border, overstaying their visa, or just speaking their mind. How about extending TPS; living up to treaty commitments on refugees; instant citizenship for Dreamers; a direct path to citizenship for all 12 or however many million undocumented *human beings* are already here?! And since we're dreaming, how about all Americans learning the <u>facts</u> -- on how immigrants build <u>up</u> our society, bring <u>down</u> the crime rate, and contribute greatly to our social fabric?! (!!!!)

That ICE agents shouldn't enter, and seize people from, our religious buildings – that's just the smallest piece of the puzzle. Deut. 23 is clear about the rights of wrongly detained folk: "(16) You shall not turn over to their master, a slave, who seeks refuge with you... (17) They shall live with you, in *any* place they may choose among the settlements in your midst ... you must not ill-treat them." Biblically, and now: we will *not* turn over those under threat of wrongful detention!

Now back to these holy buildings that ICE should never enter: the *most* common name for congregation is **Beit Knesset** -- literally 'a place where people congregate,' a House of Assembly, of community. And that's where every religious community has a choice: be more inclusive, or exclusive –

Pray and connect and learn with only folks who look and sound and think like you, staying insular, and ossified, becoming unhealthy, even obsolete? Or:

Embrace new people, new ideas, perspectives; new accents, new flavors, new

melodies, new friends, new strength <u>as</u> a community, BECAUSE we congregate with a wider circle of holy people. Let more and more houses of worship choose the latter – why? Because that's the path of loving God <u>and</u> neighbor <u>and</u> immigrant. And why? Because we need each other! [Refrain of the evening: "We need each other!"]



Last: look around; and consider this central room of a house of worship: the **sanctuary**. From *sanctus*, the sacred, the holy -- connoting safety, refuge, protection. <u>May every masjid</u>, gudwara, temple, church, and synagogue offer that refuge -- each with its own members mobilizing, plus connections *among* these myriad communities flowering.

And: since one's home is a *mikdash m'at*, mini-temple: may people be safe from roundups, in their homes! And since public spaces are our collective treasure, may all be safe on the street, at work, school, the store! And – since this very nation has, at its best, been a beacon of loving enlightened welcome – after we win this case and many others, may we again enjoy a USA that *itself* is a sanctuary, from sea to shining sea.

Amin, Om, Shanti, Sadhu, may it be so: Amen.
